

## **PARENTAL CONSENT, RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT**

My minor child, \_\_\_\_\_, (“the Minor”) has decided to participate in one or more of The4Network’s (hereinafter “T4N”) programs. This may include, although is not limited to, participating as a student for courses, being tutored, as a mentoree or as a volunteer. T4N is run by The4Network Limited (hereinafter “T4N Limited”). The Minor has my consent to attend. I understand the nature and requirements of T4N. With that understanding, it is my judgment that the Minor is qualified and able to participate in T4N. I acknowledge that the Minor’s participation in T4N is voluntary.

Due to the age of the Minor, T4N Limited requires that this Agreement be executed by me in consideration of the Minor’s being permitted to take part in T4N. I agree to and acknowledge the following:

- (1) I am the Minor’s parent or legal guardian.
- (2) I agree that the Minor will abide by all of rules and regulations and, if found in violation, may be removed from T4N either temporarily or permanently. I understand that T4N Limited may withdraw the Minor’s participation if these programs are disrupted or altered in any way by the Minor’s behavior. I further agree that as a parent or guardian of the Minor, I take full responsibility for the behavior and conduct of the Minor and any consequences resulting from his or her actions.
- (3) As parent of the Minor, I understand that there may be safety risks associated with the Minor’s participation in programs and activities designed for children. I acknowledge and agree that I have had the opportunity to ask questions of T4N Limited officials concerning these matters, and all questions have been answered to our satisfaction.
- (4) On behalf of ourselves, our heirs, executors, and administrators, I waive and release forever any and all rights for claims and damages I may have against T4N Limited (both individually and jointly), their trustees, officers, employees, and agents in any manner due to any personal injury or property loss sustained as the result of the Minor’s participation in T4N. I hereby indemnify and hold harmless from and against any and all claims, demands, judgments, losses and expenses, including, but not limited to, attorneys’ fees for personal injury or death to the Minor or damage to the Minor’s property during T4N period arising out of or resulting from the negligent or wrongful acts or omissions of T4N Limited, and their employees and agents with the exception of gross or willful misconduct.
- (5) I agree that should there be disagreements or problems with the implementation of this agreement, the laws of California will govern any resolution. I further agree that should litigation or grievances result, the forum for any lawsuit, hearing or adjudication shall be in California.
- (6) As parent of the Minor, we agree that I will promptly communicate any problems or issues associated with the Minor’s participation in T4N with T4N Limited officials. I further agree that I will promptly report and disclose to T4N Limited officials all pertinent information concerning the Minor’s ability to participate successfully in T4N.
- (7) The4Network may record, edit, use, reproduce, publish and distribute by way of any and all media and transmission, the visual and/or audio likeness of Participant and other commentaries, information, and materials the Participant may provide in connection with all classes, which includes, without limitation, Participant’s biographical information, likeness, commentaries, presentation materials, and/or performance in the class. The4Network is further granted permission to use such materials for educational, fund raising, promotional or other purposes worldwide and in perpetuity, to the extent permitted by applicable law. Participant agrees that The4Network will be held harmless from any liability that may arise regarding the production, use, and distribution of such materials as described herein, and The4Network is hereby released from any claims relating to the rights granted above.
